The Board of Supervisors of Pocahontas County, IA met in regular session pursuant to adjournment.

Members present: Chairman Louis Stauter, Clarence Siepker, JoAnn Peters, Jeffrey K. Ives, Ed Dewey.

The minutes of September 1 and 11, 2015 were approved as presented on motion of Siepker, seconded by Peters. Ayes all, motion carried.

The tentative agenda was approved as amended on motion of Dewey, seconded by Ives to include approving a letter for Midas billing for the Hazard Mitigation Plan. Ayes all, motion carried.

John Torbert, IDDA Director presented his annual report. Torbert noted it was 14 years ago that he began his tenure with the Iowa Drainage District Association and Pocahontas County Supervisor Ralph Christiansen was the association's president. Torbert noted the many challenges facing drainage i.e. Des Moines Waterworks litigation, WOTUS that is in effect in Iowa however, there are 20+ states that have not allowed the rules through litigation. The Dakota Pipeline is crossing through several counties in Iowa however Pocahontas County is not affected. The association's attorney constructed a resolution defining the placement of the pipeline and protection to county drainage to be adopted by these counties. Calhoun County was the first to adopt the resolution with the pipeline responding through the courts. The hearing for the Des Moines Waterworks litigation has been set for August 2016. This is an aggres-sive schedule for such litigation but the Judge is adamant it will happen. The annual meeting of the IDDA is set for December 4, 2015.

It was moved by Siepker, seconded by Peters to approve the liquor license for Laurens Golf and Country Club. Ayes all, motion carried.

A letter from Sheriff Lampe advised Sarah Bailey has completed her probationary period as office clerk as of September 16, 2015. It was moved by Ives, seconded by Siepker to approve the wage increase to \$15.42 effective September 16, 2015. Ayes all, motion carried.

It was moved by Siepker, seconded by Peters to acknowledge resignation of Mike Hertz as part-time dispatcher effective September 15, 2015. Ayes all, motion carried.

It was moved by Dewey, seconded by Ives to acknowledge the resignation of Jackie Bunda and Paulette Zaugg, home care aides for Pocahontas County Home Care Aide Agency effective September 30, 2015. The board appreciates their many years of dedicated services to residents of Pocahontas County, 20 years and 15 years respectively.

It was moved by Dewey, seconded by Ives to abate the current taxes due for the following parcels: Receipt#18114 - Pocahontas City - \$218.00; Receipt #15829 - City of Palmer - \$136.00; Receipt #13976 - City of Havelock - \$10.00; Receipt#13977 - City of Havelock - \$10.00; Receipt # 17889 and 17269 - Pocahontas Community Hospital - \$1,16

It was moved by Peters, seconded by Siepker to acknowledge receipt of the following Manure Management Plan: (1) Dennis and Gene Wadle Facility - ID# 58139 located in SE NE, Section 30, Cedar Township with Dennis and Gene Wadle as owners and Dennis Wadle as the contact person. Ayes all, motion carried.

It was moved by Ives, seconded by Dewey to approve the letter to Iowa Homeland Security requesting payment of \$35,764.00 through Grant #DR - 1998-0008-01 reimbursement to Midas for the development of the County Hazard Mitigation Plan. Ayes all, motion carried.

It was moved by Peters, seconded by Siepker to approve Pay Estimate No. 4 in the amount of \$59,472.00 to Reutzel Excavating for construction completed through August 20, 2015 on D.D. 21. Ayes all, motion carried.

Don Reffer, B & W Control Specialists advised the inspection of the county drainage districts was completed with the assistance of Supervisor Siepker and Gary Atherton, Engineer's Asst. and Drainage Clerk. Inspection of D.D. 29 will be reviewed today with Supervisor Stauter. There will be 13 drainage facilities treated through the 2015 fall season and the 2016 summer season each with a not to exceed cost. It was moved by Ives, seconded by Siepker to approve the schedule as provided. Ayes all, motion carried.

Jack Moellering, County Engineer advised he had nothing for the board. Supervisor Stauter queried if the drainage right-of-way for Jeff Halder had been staked out as Halder needs to replace his fence for cattle that was removed for repairs noting he wants to keep his fence off the right-of-way. Atherton indicated nothing done.

It was moved by Peters, seconded by Siepker to approve the bill from Bolton & Menk, Inc in the amount of \$327.00 for JT. D.D. 171 and forward to Humboldt County for approval. Ayes all, motion carried.

Don Etler, P.E. with Bolton & Menk, Inc of Spencer presented the Plans and Specifications for D.D. 41, Br 22 and would like to set the Hearing for Bid Letting for September 29, 2015. It is noted the work will be required to be completed by April 1, 2016 so the work with be done this fall and possibly through the winter. Fewer bids will be expected due to the shortened completion date. It was moved by Peters, seconded by Siepker to approve the Bid Specifications and set 3:00 p.m. September 28, 2015 for the bid letting and the award of the bid to be September 29, 2015. Ayes all, motion carried.

Russ Jergens, EMA Director and E911 Coordinator advised the 911 Commission reviewed bids for a new generator. The low bid of \$72,000.00 was submitted by EMC of Fort Dodge for a 125 KW diesel generator. He is applying for 911 funding to pay for the generator. It will be placed where the old AC unit is currently sitting. Jergens advised the 911 budget will need to be amended and requested the publication of the amendment be paid by the Board of Supervisors. It was moved by Ives, seconded by Dewey to approve payment of the 911 budget amendment. Ayes all, motion carried.

The board recessed to the Assembly Room for drainage hearings for D.D. 41, BR 11 and D.D. 178 Informational meeting. The minutes are recorded in the appropriate drainage records.

The board returned to the Board Room at 3:00 p.m. to continue the regular board meeting. Supervisor Dewey noted he talked with Eric List, Pocahontas City Administrator regarding D.D. 53, BR 25-28 and he was unable to find anything stating the city was responsible for this branch of the district. Jim Hudson, Drainage Attorney advised he has researched his files and Auditor Bunda has researched the drainage files and while there have been agreements of the city taking over various repairs the branch of the drainage district remains with the drainage district. A levy for the outstanding balance was discussed. Auditor Bunda advised a reclassification schedule will need to be found, land records checked, and all appropriate information entered into the computer system. A levy cannot be made until next tax year.

Supervisor Ives has communicated with Keith Wirtz, Palo Alto County Supervisor regarding JT. D. D. 36 and the outstanding balance. Ives noted he wanted an assessment made. Auditor Bunda advised this is a joint district and it will depend upon the approval of Palo Alto County.

Supervisors Weekly Reports: Stauter attended the FEMA Flood Zones meeting, County Conservation Board meeting as liaison, and canvassed the school election. Siepker attended the Hwy 20 meeting, surveyed drainage districts for brush control, and canvassed the school election. Ives tended to issues for recycling and canvassed the school election.

There being no further business the board adjourned.	•
