The Board of Supervisors of Pocahontas County, IA met in regular session pursuant to adjournment.

Members present: Chairman Vincent L. Triggs, Louis Stauter, Paul Beneke, Jeffrey K. Ives. Absent: Ed Dewey.

The minutes of January 2, 2014 were approved as read on motion of Beneke, seconded by Stauter. Ayes all, motion carried. (No meeting January 7, 2014)

The tentative agenda was approved as amended on motion of Stauter, seconded by Ives to include approve hourly pay for new hire and add the omission of UDMO annual report and funding request. Ayes all, motion carried.

Sarah Winkler, County Treasurer provided the Statement of Condition, Banks Certificate of Balance and Semi Annual Report demonstrating the dollars of monies on hand of \$9,209,226.39 as counted by the Board of Supervisors January 2, 2014 and the Quarterly Investment Report again demonstrated the \$600.00 Cash in office, \$3,266.01 in NSF check, \$3,002,406.35 in CD's, \$945,000.12 in Stamped Drainage Warrants, \$200,269.93 in Drainage Improvement Certificates, \$5,057,683.98 in deposit of banks for a total of \$9,209,226.39 accounted for. There were three (3) CD's renewed each in the amount of \$500,000 for six months, and \$17,443.55 interest earned. There was revenue of \$3,969 generated from 569 driver's licenses issued for the quarter. Following review it was moved by Beneke, seconded by Stauter to approve the reports of the treasurer as presented. Ayes all, motion carried.

Jamey Whitney, Executive Director and Cinda Joynt, Outreach Director presented their recap of the past year of services provided this past year. It is noted there were 387 families and985 individuals served through the various programs of the agency. Pocahontas County UDMO Outreach served 346 homes with \$156,200.00 in heating assistance accounting for the majority of the \$187,552.34 services provided to our county residents. There were 42 households served impacting 111 children through the Back-to-School program, 50 households representing 147 children was served through the Hats & Mittens, 23 received assistance through the Elderly Chore Service program, 28 quilts were given, and 82 meat certificates to name a few of the programs that provided assistance to Pocahontas County residents in their time of need. The agency's funding request of \$14,080 to assist in supporting the outreach office has been unchanged for several years reflecting a return of \$13.32 for every dollar the county invests in this program. The board will consider the funding request through the budgeting process.

Jack Moellering, County Engineer is preparing his budget and provided informational items that will impact the upcoming budget. He advised that Faith Lutheran Church does wish to purchase the old copy machine that was not sold at auction and will pay the \$50.00 upon picking up the machine. Moellering advised he has discussed the surveying of properties for ROW needs for the N65 project with Jeff Krueger. It was moved by Beneke, seconded by Stauter to approve the hiring of Krueger Surveying for this project. Ayes all, motion carried.

It was moved by Ives, seconded by Beneke to appoint Sherry Williams as the Compensation Board member to represent the county auditor for a four year term. Ayes all, motion carried.

It was moved by Ives, seconded by Stauter to approve the annual Construction Evaluation Resolution whereby the board must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305 with the board's recommendation to the DNR being based on the final score of the master matrix or based on reasons other than the matrix. The chairman called the question with the following recorded vote: ayes – Stauter, Beneke, Ives, Triggs; nays – none; absent – Dewey. Whereby the resolution was adopted and is on file in the auditor's office.

It was moved by Stauter, seconded by Ives to approve the hourly rate of \$16.00 for the parttime employment of David Stall as Environmental Health Specialist effective January 6, 2014. Ayes all, motion carried.

It was moved by Ives, seconded by Beneke to acknowledge receipt of the following Manure Management Plans as follows: (1) Nehman's facility ID# 59264 located in the NE SE, Section 1, Williams Township, Calhoun County with Nutra Tech, LC as the owner and Rusty Kosky as the contact person; (2) Cummins South – facility ID# 65112 located in the SW SE, Section 32, Cummins Township with Hawkeye Partners, LLP as the owners and Brian Ritland as the contact person; (3) Cummins North – facility ID# 65111 located in the SE SW, Section 16, Cummins Township with Hawkeye Partners, LLP as the owners and Brian Ritland as the contact person. Ayes all, motion carried.

It was moved by Beneke, seconded by Stauter to set Wednesday, January 29, 2014 as the continued hearing date for D.D. 8 at 1:30 p.m. in the Assembly Room, Courthouse to finalize the engineer's report. Ayes all, motion carried.
