The Board of Supervisors of Pocahontas County, IA met in regular session pursuant to adjournment.

Members present: Chairman Vincent L. Triggs, Louis Stauter, Paul Beneke, Jeffrey K. Ives, Ed Dewey.

The minutes of April 1, 2014 were approved as read on motion of Beneke, seconded by Ives . Ayes all, motion carried.

The tentative agenda was approved as amended on motion of Stauter, seconded by Dewey to include reset annexation and reclassification hearing for Drainage District 41, Br 6 and include claims inadvertently deleted from agenda, and Ray Seehusen to discuss drainage concerns. Ayes all, motion carried.

The board considered the JT Resolution Road Agreement with Humboldt County for P-19 Crossing. Following review it was moved by Beneke, seconded by Stauter to adopt the resolution setting the date for public hearing. The chairman called the question with the following recorded vote: Ayes – Stauter, Beneke, Ives, Triggs; Nays – none; Abstained – Dewey (employee of Martin Marietta). Whereby the chairman declared the resolution duly adopted to wit:

RESOLUTION 2014 – 4 - #5

Whereas Humboldt County and Pocahontas County are owners of Highway P-19 which is located with Humboldt and Pocahontas Counties, as is more particularly described as follows:

A portion of the existing right-of-way of County Highway P-19 located within the E1/2 of Section 25, Township 92 North, Range 31 West of the 5th Principal Meridian, Pocahontas County, and the W1/2 of Section 30, Township 92 North, Range 30 West of the 5th Principal Meridian, Humboldt County, Iowa.

Whereas Humboldt County and Pocahontas County, grantors, propose to convey an easement to martin Marietta materials, Inc., for the purpose of grantee's constructing, using, and maintaining an atgrade crossing in association with grantee's quarry operation subject to certain conditions.

Be It Resolved that pursuant to Section 331.261, code of Iowa, the Humboldt County Board of Supervisors hereby sets a public hearing on the 7th day of April 2014, at 8:45 a.m. in the Board Room of the Humboldt County Courthouse and the Pocahontas County Board of Supervisors hereby sets a public hearing on the 15th day of April 2014, at 11:00 a.m. in the Board Room of the Pocahontas County courthouse, both for the purpose of hearing on the approval of a Road Crossing Agreement between Martin Marietta materials, Inc., Humboldt County, Iowa and Pocahontas County, Iowa regarding County Highway P-19.

The board next considered the 2014 Applications for Exempt Lands –Open Prairie, Forest Cover, Streams, etc. It was moved by Beneke, seconded by Stauter to approve the applications as filed with the Assessor's Office. Ayes all, motion carried.

It was moved by Dewey, seconded by Ives to acknowledge receipt of the following Manure Management Plans: (1) Wenk – facility ID# 67313 located in NE SE, Section 32, Swan lake Township with Kyle Wenell as owner and contact person; (2) Seehusen Finisher – facility ID# 61832 located in SE SW, Section 30, Sherman Township with The Maschhoffs as owners and Maschhoff Environmental, Inc. as the contact person; (3) Wadle Turkey Farm – facility ID# 65822 located in the NW NW. Section 30. Cedar Township with Dennis and Gene Wadle as the owners and Dennis Wadle as the contact person. Ayes all, motion carried.

Roger Peters advised the board he was interested in tax sale property in Rolfe. The building will be renovated to use as his repair shop business that is currently housed in his garage. The building is in good condition with the exception of the flat roof in need of repair. Sarah Winkler, County Treasurer advised there are three (3) lots and three (3) tax sale certificates with a total of \$2,220.00 in taxes and \$3,065.00 in penalties and interest for a total of \$5,285.00 to be considered. Following discussion it was

moved by Ives, seconded by Stauter to assign Tax Sale Certificates # 1995-95082 for Lot 8, Blk 3 and abate the \$1,209.00 to redeem the tax sale and the \$470.00 current taxes, interest and penalties; Certificate #2012-136 for Lot 9, Blk 3 and abate the \$1,126.00 taxes to redeem the tax sale and the \$\$801.00 current taxes, interest and penalties; Certificate #1995-95084 for Lot 10, Blk 3 and abate the \$1,209.00 to redeem the tax sale and the \$470.00 in current taxes, interest and penalties for a total of \$5,285.00 to be abated; with a reminder to proceed with legal counsel to complete the notification process and cannot access the building until the 90 day period has ; the entire project must be completed within one year. Ayes all, motion carried.

Dan Paulsen, EMS Director at the Hospital provided an update of the ambulance services throughout the county. He highlighted the training that has been available in the past and various trainings and equipment the department has been able to acquire to enhance the services of the EMTs throughout the county. The board commended Dan for the communities' cooperative efforts to assure Pocahontas County residents have the best ambulance services available to them.

Jack Moellering, County Engineer presented the Five Year Program plan for the board's review. The board considered the various projects that are proposed to be completed with the main focus on the bridges to be replaced. Mike Marine and Don VonGorkum were present to discuss the need for the bridge of 28/33 Des Moines Township. Following discussion it was moved by Ives, seconded by Dewey to request Moellering determine the feasibility of reinforcement versus replacement of said bridge with a report of the study in the future. Ayes all, motion carried.

Ray Seehusen and son Peter requested the board's intervention in allowing Seehusen to cross another landowner's property to install a private tile to Drainage District No. 21 open ditch. The board advised while Seehusen by virtue of being in the drainage district has the right to drain to the open ditch but the board cannot force another landowner to respond. Seehusen suggested establishment of a subdistrict. The board advised it is in the best interest of all parties to reach an agreement rather than endure the expense and disharmony amongst neighbors. Seehusen states he has tried to no avail. Seehusen was reminded that he has been through this process in previous years and with appropriate wording and mutual agreement through discussions an agreement was accomplished. Seehusen advised he does have an attorney.

Auditor Bunda advised of the request for an ad to be placed in the upcoming Farm News edition promoting wind energy. It was moved by Ives, seconded by Dewey to place an eighth page black and white ad in the special edition. Ayes all, motion carried.

Auditor Bunda reported that Copper Cottage of Spencer has found a replacement heating/cooling unit for the board room at a cost of \$1,595.00 with approximately \$50.00 in freight plus installation. It was moved by Beneke, seconded by Ives to purchase the heater with installation by Copper Cottage. Ayes all, motion carried.
