Ashley Bennett, Asst. County Attorney advised the board the Iowa Bar Association is interested in creating a program to promote rural areas as employment areas for young attorneys beginning their

practice. There are several groups coming together in person and via telephonic conferencing to review and consider ways to enhance young attorneys to rural areas of this state.
