Resolution Adopting Official County Seal for Election Ballots

WHEREAS, Iowa Code Section 331.301(8) requires all counties to have a County Seal; and WHEREAS, Iowa Code Section 43.36 requires that the County Seal shall appear upon the ballots; and WHEREAS, Iowa Code Section 331.552(4) mandates the requirements for an official County Seal provided by the County; and WHEREAS, the Pocahontas County Board of Supervisors, in compliance with the above Iowa Code Sections, has made an official Pocahontas County Seal to be adopted and to be used on all election ballots in Pocahontas County. NOW THEREFORE, BE IT RESOLVED that the Pocahontas County Board of Supervisors hereby officially adopt the County Seal, shown below, as an Official Seal for Pocahontas County, Iowa.
